- 2. Roll call, introductions and welcome by Supervisor Roy Schwickerath
- 3. Motion by Joel Voaklander Mitchell County and second by Ken Abrams Worth County to approve today's agenda and the minutes of July 22, 2015.
- 4. With the creation of a separate CSS Agency Fund July 1, 2015, the Butler County Board of Supervisors no longer needs to approve claims for CSS. Therefore the CSS Board must identify a Board representative to review and approve each claim run. Review and action to authorize the CSS Chair to designate the Secretary/Treasurer, Vice Chair or himself to review and sign off on each claim run pending eventual presentation and approval by action of the CSS Board. - 8. Bob introduced Director Palmer. Bob shared a powerpoint with an overview of CSS's Mental Health Redesign after the first full year.
- Director Palmer then shared a power point in regards to the Mental Health System Update. (the powerpoint is on the DHS website)

- 10. Provider feedback by Jim Aberg. Wondering about reinvestment dollars. Intends to have a region wide advisory mtg next month. Any investment will come out of our reserves. CSS work activity mtg last month was welcomed. Need to focus on job development. Stop language of sheltered work. Asked for transition time. Questions sent to Jim asking role of CSS with the MCO's rolling out. Do we need to do a gap analysis on services? CSS has been gathering information on this.
- 11. Last year in October CSS hosted a behavioral health and law enforcement conference that was well received by our local law enforcement. We would like to make this an annual event to build on the efforts we are making with mental health services in our jails and create behavioral interventions that will divert individuals from justice involvement.
